

How To Request Reasonable Academic Accommodations at Warner Pacific College

Students with disabilities who meet the academic and technical standards required for admission or participation in Warner Pacific College's programs and activities cannot be denied access. Students with disabilities requesting reasonable academic accommodations at Warner Pacific College will be considered on an individual basis pursuant to the regulations of the Americans with Disabilities Act (ADA) as well as Section 504 of the Rehabilitation Act of 1973. The student's condition(s) must meet the definition of a disability as described in 42 U.S. Code § 12102. Refer to the Warner Pacific College <u>Disability Resource Guide</u> for additional information.

Who Can Request Academic Accommodations

Students with disabilities attending Warner Pacific College courses and programs. Contact the Disabilities Resource Coordinator <u>Jann McCaul</u> (503.517.1577) to obtain the necessary forms and initiate the process.

Documentation of Disability is Required

In order to determine if the student's condition qualifies as an ADA disability, sufficient medical documentation will need to be provided to the Disabilities Resource Coordinator (DRC) at Warner Pacific College. Medical documentation is defined as generally providing:

- A description of the nature, duration and severity of the student's disability.
- A description of the activities that the student is able to perform and/or restricted from performing in the educational environment.
- The documentation substantiates through evaluations or tests why the requested reasonable accommodations are needed.

Please read the medical documentation criteria, **on page two**, for sufficient medical documentation requirements.

For short-term conditions or recent injury

Students without a protracted disability (i.e. sprain or broken bone) may not be eligible for academic accommodations under the ADA's definition of disability at Warner Pacific College. However, the DRC may be able to provide some temporary assistance for some types of short-term injury or temporary conditions. Sufficient medical documentation of the recent condition will be required.

Sufficient Medical Documentation Criteria

Students requesting accommodations should be prepared to provide sufficient medical documentation that describes the student's disability, the limits to major life activities as defined by the ADA, and generally meets the following criteria:

- The diagnosis is specifically stated.
- The report is current (within the past three years).
- The duration of the disability.
- Medical professional's credentials are appropriate to diagnosis the disability.
- Medical documentation is written on the medical professional's letterhead, dated and signed by the treating/evaluating professional. [Not a prescription pad.]

Additional medical information that is helpful

- o Description of the disabling symptoms as supported by the diagnosis.
- Major life activity limitations are described.
- o Recommended academic accommodations as warranted and reasonable.

Many IEPs and 504 Plans do not meet these documentation criteria. Additional documentation may be required or requested prior to approval of accommodations.

Receiving Accommodations in a Timely Manner

To receive accommodations promptly, the medical documents will need to be delivered to Warner Pacific College's Disabilities Resource Coordinator. The medical documents should not be sent to other campus departments as this delays the process, and other departments may not maintain the same confidential processes as the DRC.

The DRC does not provide a medical request form for documentation. Students may want to take a copy of this explanation page to the medical professional to help develop sufficient medical documentation of the disability.

Upon receipt of sufficient medical documentation along with the student's Warner Pacific College accommodation request forms by the DRC, the documentation will be reviewed to determine the student's eligibility for reasonable academic accommodations. **Accommodations may take an additional two to six weeks to establish depending on the nature of the request.**
