Years 1 & 2: Complete the ASOT - Business at Portland Community College

 Complete at least 90 quarter credits (60 semester credits) of transferrable coursework as part of your ASOT-Business curriculum
- General Education Core
 The WPU lower-division general education core requirements are fully met by the completed ASOT-Business degree.
